118.DRAFT BUDGET

In terms of insurance, it was noted that (1) Zurich has quoted a 3 Year Long Term Agreement of £512.16 and a 1 Year Agreement of £539.52 (including IPT) and (2) Came and Company – unwilling to quote so far in advance but suggest for budgeting purposes £695 including Insurance Premium Tax (IPT) which is currently charged at 12%.

The draft budget 2019/20 was discussed and noted. When the tax base is received it will be brought back to the Parish Council as the basis for the precept calculation.

119.HIGHWAY MATTERS

Potholes - Haydon Hill from Kilmersdon to the BANES boundary: An inspection of the site had been arranged (ref.529552) and the Parish Council conveyed its thanks for the necessary remedial works which were undertaken to a good standard.

Jack and Jill footpath is extremely slippery due to leaves and moss and is a significant hazard in this route to school. Whilst they have been cleared to an extent by SJH Services the land belongs to Somerset CC. Agreed to continue to ask Somerset CC for the leaves to be cleared regularly to keep the footpath safe for school children.

120.PLAYING FIELD

From the weekly play park checks -

- The rear of the noticeboard is showing signs of wearnoted.
- Damage to a seat of a picnic bench, possible rot underneath – Cllr Morse to assess what is required
- Rear bars of baby swing are cracked to monitor the rubber around the bars.
- The framework and in particular the top bar of the swings needs painting – noted
- The branches overhanging the zip wire require cutting back. Agreed at a cost of £195.
- Loose football posts had been assessed by Cllr Brand and it was agreed to continue to monitor these.

The footpath at the playing field is overgrown with weeds. **Agreed** to contact the landowner stating that the Parish Council has discovered that it is not its land and requesting that it be maintained on a regular basis. Currently it is overgrown with vegetation and is a trip hazard.
